Payment Information and Options:

1. Personal checks are accepted at the address listed at the top of the form. Please make all checks payable to GARA (Green Acres Recreation Association).
2. We can accept electronic payments through PayPal. When sending it, please comment "GA summer 2024" and your family's last name. Payment may be sent to garadues@gmail.com.
PLEASE NOTE: You must include a \$20 processing fee when using PayPal.

Additionally, you MUST SEND THE COMPLETED MEMBERSHIP FORM to the listed address to ensure that your membership is on file. We cannot process membership forms through PayPal.

3. **Your application cannot be processed if your maintenance check is not included with your paperwork.** We will not deposit your check for maintenance fees until the end of the 2024 season. If your family completes 8 volunteer hours during the season, we will void your check. Otherwise, we will notify you when your check is going to be deposited in early fall.
(Please postdate check: August 20, 2024.)
4. **All membership dues MUST be paid in full by May 20, 2024. We cannot guarantee that your membership will be processed by opening day if it is not submitted by May 20. Families will only be permitted to use the facilities when paid in full.** Payment plans are available. Please email our membership coordinator, Janice Scott, at garamembership@gmail.com for information regarding a payment plan that can be put into place from February through May.
5. Per the GARA bylaws, there is an opt-out fee for all bondholders who wish to retain their bond but will be inactive during the 2024 season. Currently, this fee stands at \$50. It must be submitted with a membership form that indicates you will opt out for the 2024 season.
